





Homeless and drunk people like lying right in front of the door. They stock the door and no room for us to avoid them and then get in. One night, I came home late, a crazy homeless sit in front of the door. I was so afraid. So I just stood outside and observed when would they leave. After one hour, they left. It's late night. I could not describe how I was franked out by them. Another day, in the morning around 7am, I needed to leave early to attend an exam, one homeless lied in front of the door, I had no choice but step over him. But he suddenly woke up, he hold my leg and did not let me move. I was almost franked out to die. They are so crazy and dangerous. I can not live everyday like this. This is my place.
