### NEW YORK SENIORS WILL MARCH ON STATE CAPITOL

All senior citizens clubs in New York are being alerted to rally at the State Capitol in Albany in March to urge legislators of the Empire State to resolve some of the increasing problems of the elderly.

Principal sponsor of the event will be the Congress of Senior Citizens of Greater New York, with headquarters in Manhattan, an organization of over 252 affiliated clubs—though seniors from all parts of the State are being invited to join the rally.

Walter Newburgher, President of the Congress and a Vice President of the National Council of Senior Citizens, and Assemblyman Albert H. Blumenthal, Deputy Minority Leader of the State Assembly, organized conferences in four of New York City's five Boroughs in December to alert club leaders to the need for a confrontation with State lawmakers at an early stage in the legislative session. In question-and-answer sessions with club delegates, the Deputy Minority Leader collected the views of the seniors on possible remedial legislation to meet some of their increasing problems.

Congressman Jonathan Bingham, New York City's Deputy Mayor Edward A. Morrison, Deputy Commissioner of the Office on Aging Roberta Spohn and William R. Hutton, Executive Director of the National Council of Senior Citizens, were among the speakers at the New York City conferences.

Newburgher told the club delegates attending the conferences that approximately 160,000 elderly poor in New York City were eligible for public assistance income maintenance, but only 79,000 actually received it.

#### **Failure Of Congress**

He claimed that because of Congress's failure to mandate a "pass through" provision of more than four dollars, thousands of poor elderly New Yorkers receiving low Social Security benefits and requiring supplemental public assistance to meet the State's subsistence level were being subjected to "harsh discrimination."

"What the Congress has given with one hand with a Social Security boost, the State has taken away from public assistance with the other hand," said Newburgher, adding:

"For thousands of elderly New Yorkers the recent 20 per cent Social Security boost has pushed them beyond the limits of State eligibility for Medicaid, rent subsidies and food programs."

Congressman Bingham said he hoped Congress would immediately review the effects of the recently-passed H.R. I Social Security amendments and seek to correct the retrogressive provisions. No Social Security increase should cause denial of a veteran's benefit, loss of access to Medicaid, or denial of tenancy in low-cost public housing, he noted

#### **Harassment By Landlords**

Deputy Mayor Morrison said a law passed by the State Legislature last year was indirectly subjecting many elderly in rent-controlled apartments in New York City to severe harassment by landlords.

The new State law provides that when a tenant leaves a rent-controlled apartment the landlord may raise the rent to any level he chooses.

In New York City, rents of controlled apartments were raised 7½ per cent last year to all tenants with an income above \$5,000 a year. A similar increase will be permitted this year for all controlled apartments which have not yet reached a maximum base rent established by the City Rent Commissioner.

Deputy Mayor Morrison charged there had been many complaints of landlord harassment of tenants to get them to leave controlled apartments so landlords could skyrocket the rents for profit. "The State's new tenant-vacancy law is sounding the death-knell of rent control in New York City," he said

Newburgher said that the Albany rally would also focus attention on the need to utilize New York's Federal revenue-sharing funds to improve services for the elderly throughout the State.
